Dear Friends of CRS,

**SHINE BRIGHT FOR OUR COMMUNITY!** That's what we do at Community Resource Services (CRS). The past 12 months have been a success for CRS, accomplishing many goals designed to alleviate the effects of poverty facing members of our community. Over 460 different families made up of 1,261 people (151 seniors, 529 adults and 581 children) reached out for help through one or more of our various programs. We addressed issues of food insecurity by distributing 117,500 pounds of food—the equivalent of \$198,575—and provided financial assistance 245 times to prevent eviction or utility disconnection. We helped send 221 school-aged kids back to school in August with all the supplies they needed through our Back-to-School Readiness program; 274 children received Christmas gifts, pajamas, coats and boots through our Santa's workshop; and we hosted a series of Summer Farmers' Markets (thanks to Second Harvest Food Bank of North Central Ohio) to give our clients better access to fresh fruits and vegetables and encourage healthier eating habits.

**We couldn't have done any of that without the generous support we receive from countless patrons and friends.** We are blessed to have community support from so many individuals and corporations who contribute through various fundraising efforts, along with outstanding community partners like The Alyce J. and Ann J. Metka Foundation, The City of Avon, The City of Avon Lake, Avon Lake Regional Water, Community Foundation of Lorain County, Community West Foundation, the Hooks for Hunger Team, Lorain County Community Action Agency, The Nordson Corporation Foundation, The Salvation Army and The Second Harvest Food Bank of North Central Ohio. What do all these constituents have in common? They believe in our mission and enable us to help the residents of Avon and Avon Lake who need a helping hand.



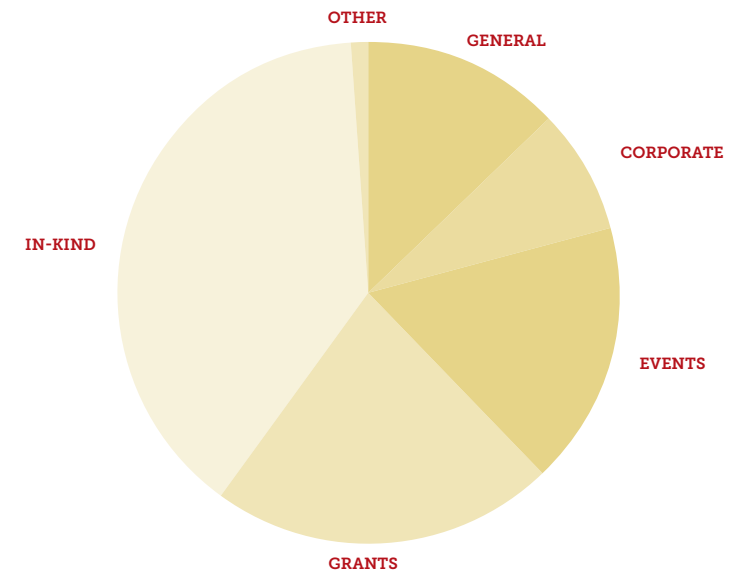

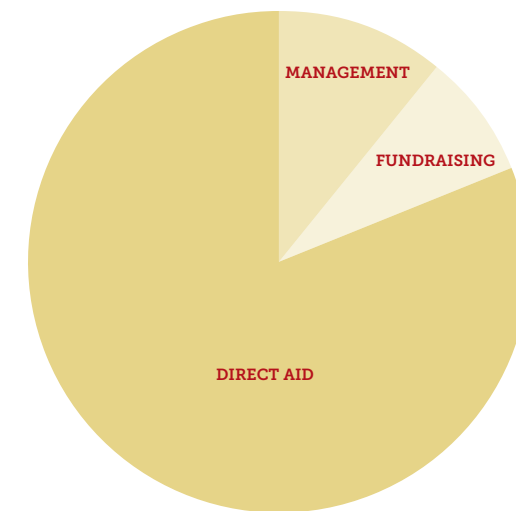
